AGREED FINAL JUDGMENT ORDER

THIS CAUSE COMING TO BE HEARD on the agreement of all parties to this cause to enter an Agreed Final Judgment Order, the parties having reported to the Court that they have settled, compromised, adjusted, and adjourned all matters and issues between them pertaining to the above entitled cause; and the parties having further reported to the Court that they have agreed to and consent to be bound by the terms of the agreement hereinafter set forth; and the Court being fully advised in the premises:

NOW THEREFORE, UPON AGREEMENT OF THE PARTIES HERETO, THE COURT FINDS AND ORDERS AS FOLLOWS:

1. That Respondent, Gilbert Arreola, is hereby found to be guilty of minor indirect criminal contempt of court for holding himself out as an attorney, and for engaging in the unauthorized practice of law by providing legal advice and services, to the individuals listed below in the matters specified:

- A. Jose Flores and Rocio Rios in immigration petitions before the United States Citizenship and Immigration Services ("USCIS") / between 2014 and 2016;
- B. Elba Maldonado and Jose Murillo Pantoja in immigration petitions before the USCIS between 2014 and 2016;
- C. Laura Flores Maldonado in an immigration petition before the USCIS between 2015 and 2016; and
- D. Jesus-Enriquez-in-an_immigration-petition-before-the-USCISbetween 2016 and 2017.



2. Respondent, Gilbert Arreola, is hereby sentenced to one year of non-reporting probation and a fine of \$500 and court costs.

3. Respondent, Gilbert Arreola, is hereby ordered to make restitution totaling \$18,270; to be paid as follows: \$2,180.00 to Jose Flores and Rocio Rios; \$6,990 to Elba Maldonado and Jose Murillo Pantoja; \$3,450 to Laura Flores Maldonado; and \$5,650 to Jesus Enriquez. By December 21, 2018, Respondent shall deliver the restitution in the form of certified checks or money orders payable to the above-named individuals, respectively, to the Attorney Registration and Disciplinary.

4. Respondent, Gilbert Arreola, is hereby permanently enjoined from engaging in any acts of unauthorized practice of law in Illinois by holding himself out as an attorney, lawyer, or counselor at law in this State, or by undertaking the provision of legal advice or services on behalf of others in this State, without first obtaining authorization from the Illinois Supreme Court to practice law.

5. Respondent, Gilbert Arreola, is hereby ordered to remove any signage or other indicia of authorization to practice law from any location in which he maintains a presence, including any internet site under his control, and to destroy and cease and desist from the use of any business cards or letterhead, or other documents or materials, whether online or otherwise, in which he holds himself out as an attorney, lawyer, or counselor at law, until he obtains authorization from the Illinois Supreme Court to practice law.

6. Failure to comply with any provision listed herein will constitute a violation of the terms of probation imposed by this order.

7. The parties agree to waive any rights of appeal related to this Agreed Final Judgment Order.

8. That this Court reserves and retains jurisdiction over the above-entitled action for the purpose of permitting the parties to this Agreed Final Judgment Order to apply to this Court for such further orders and direction as may be necessary for the enforcement of this Agreed Final Judgment Order.
