Hartigan, Sosin compete in race for 3rd VP

Other contested race is for Under-37 Board seat for Cook

he race to elect a new 3rd Vice President from Cook County is almost here. Here's what Russell W. Hartigan and David B. Sosin have to say on issues facing our association.

How has your legal career prepared you to

Russell W. Hartigan: I have been involved in a small firm environment for over 30 years, which is the majority of my career. This has allowed me to practice in multiple legal areas and given me the freedom to involve myself heavily in the ISBA. I have seen the organization from inside and out.

David B. Sosin: First and foremost I have and will always be a practicing lawyer. That experience and orientation is necessary to serve as President of our association. I currently serve on the Board of Governors and have served as ISBA Bar Foundation President, local bar president, ISBA Assembly member and committee chair.

What do you feel ISBA members want from their Association?

Hartigan: Members want the ISBA to assist them in their practice, whether through technical assistance, marketing, CLE, Fastcase or legal/ethical advice. ISBA allows networking for attorneys to help market their practice. I have worked in the trenches writing

articles and speaking at ISBA seminars. It allows me to hear from members on a one-to-one basis.

Sosin: Continuing legal education, access to online research tools and social interaction are important expectations of the membership. Our representation of the profession to the public, lobbying efforts, bar services and protection of the practice of law as a profession are valued by our members as well.

What is the most pressing challenge facing the legal profession?

Hartigan: Making sure there is a viable job market for young lawyers and helping our own members "reinvent themselves" to a changing legal environment. My goal is to try to help members with their practice and keep ISBA a leading bar with a focus on membership, to help with practical tools in members' law practices.

Sosin: Maintaining balance in the personal and professional demands placed upon us is of paramount importance on an individual basis. Professionally the most pressing issue facing the legal profession is the challenge of providing quality legal services to our clients and the underserved in a professional and efficient manner.

Wild card question: This is a Cook County race, so do you root for the Cubs or the Sox?

Hartigan: As a child, my father took me to both Cubs and Sox games. I started out as a Sox fan in grade school, but grew more into a Cubs fan through efforts of my next-door neighbor (Dan Leahy of Roddy Power & Leahy). I am more of a Cubs fan, but go to games at both parks – I am not a Sox hater.

Sosin: While I am a lifelong White Sox fan, I still love watching the very heated rivalry between the Cubs and Cardinals, enjoying games in St. Louis with both our Young Lawyers Division and the Illinois Bar Foundation. I'd love to see all three teams in the postseason someday.

The winner of the 3rd Vice President race will serve one year in each of the three vice presidential offices and become president in 2017. Following Paula H. Holderman in the office of president will be **Richard D. Felice** of Wheaton, Umbero S. Davi of Willowbrook and Vincent F. **Cornelius** of Wheaton.

3 female supreme court justices to speak at Women's History Month event

panel of six female Illinois justices, including the three who serve on the Illinois Supreme Court, a chief judge and ISBA President Paula H. Holderman will headline "Myra Bradwell: The Practice of Law in the Wake of Her Legacy," a panel discussion at Northern Illinois University, DeKalb, on Friday, March 21, from 1-5 p.m.

In celebration of Women's History Month, the program panelists will discuss the progress women lawyers have made since Myra Bradwell was denied admission to the Illinois bar because of her gender in 1893. Panelists will include Illinois Supreme Court Chief Justice Rita B. Garman; Supreme Court Justices Anne M. Burke and Mary Jane W. Theis; First District Appellate Court Justices Joy V. Cunningham and Shelvin Louise Marie Hall; Second District Appellate Court Justice Susan F. Hutchinson; and Diane P. Wood, chief judge, U.S. Court of Appeals for the 7th Circuit. Jennifer K. Gust, a partner in Hinshaw & Culbertson, LLP, Chicago, will also participate.

President Holderman will moderate the discussion, focusing on personal career obstacles and the future for women in the profession. A copy of Myra Bradwell: In Light of Experience, a book by state historian John Lupton, will be given to each attendee.

"Today, one out of three lawyers is a woman, and female enrollment in U.S. law schools is almost 50 percent," said Holderman, the fourth woman president of ISBA. "But the impressive increases are tempered by the continuing challenges facing women lawyers. Women still aren't paid at the same level as men, nor do they have the same opportunity to become equity partners at law firms, judges, or corporate counsels."

The program is presented by the ISBA's standing committees on Women and the Law and Racial and Ethnic Minorities and the Law, and NIU College of Law. For further information or to register, visit www.isba.org/ cle/2014/03/21/myrabradwell. ❖

he General Assemby has started its spring session, and the following are some of the bills currently pending.



HJRCA 1 (Lang, D-Skokie) amends the Illinois Constitution to give crime victims standing as a party in criminal proceedings.

UM/UIM arbitration. House Bill 5575 (Zalewski, D-Chicago) amends the Insurance Code to make arbitration binding in UM cases regardless of the amount awarded. Under current law, arbitrators' decisions are binding only if the award doesn't exceed \$50,000 for bodily injury to or death of any one person or \$100,000 for bodily injury to or death of two or more persons in one motor-vehicle accident.

Sale of distressed condominium units. Senate Bill 2664 (Hastings, D-Matteson) seeks to protect innocent purchasers of foreclosed condominiums units. It amends the Condominium Property Act to stop the current practice in which purchasers of distressed condominium units dis-

cover at the closing table that they owe back assessments to the association. Under the current statute, there is no mechanism to determine the amount of back assessments and other charges that the purchaser will be liable for.

It clarifies and caps the total amount the purchaser may be liable for-no more than an amount equal to the unit's unpaid regular monthly assessments for the nine-month period immediately preceding the judicial foreclosure. This maximum amount can include attorney's fees and costs incurred by the association prior to closing because of the nonpayment of these assessments.

It will apply to distressed units in a purchase at a judicial foreclosure sale (other than by a mortgagee) and a purchase from a mortgagee that acquired title through a judicial foreclosure, a consent foreclosure, a common-law strict foreclosure, or the delivery of a deed in lieu of foreclosure.

The proposal also improves the notice provisions to prospective purchasers to be more clear and timely by requiring the board of managers to produce for the seller and the prospective purchasers

within 14 days information about the condominium unit, such as a copy of the condominium instruments, amounts due, and any rules and regulations. Current law allows 30 days, which is often too slow, and the proposal allows the Board the flexibility to do it either electronically or in writing. Assigned to Senate Judiciary Committee.

Probate Act and child's award. Senate Bill 2904 (Silverstein, D-Chicago) amends the section of the Probate Act of 1975 for the child's award. It replaces references to "adult dependent child" with "adult child."

Mechanics Lien Act. House Bill 5663 (Sims, D-Chicago) makes the Mechanics Lien Act inapplicable unless there is a written and executed contract to improve the lot or tract of land or for the purpose of improving the tract of land or to manage a structure under construction.

Ticket quotas prohibited. Senate Bill 3411 (Manar, D-Bunker Hill) prohibits a county or municipality from requiring a law enforcement officer to issue a specific number of citations or warnings within a designated period of time. It also prohibits a county or municipality from using the number of issued citations by an officer as a means to evaluate that officer. Makes it an unfair labor practice to require a peace officer to perform a duty that conflicts with the provisions of this amendatory Act.

Small Estate Affidavit. Senate Bill 2985 (Bivins, R-Dixon) expands the Small Estate Affidavit (SEA) to do the following: (1) Clarifies that all of the decedent's known unpaid debts must be listed and creates classes of debts similar to the classification of creditors in the Claims Against Estate Article in the Probate Code. Includes in the form an acknowledgement that these claims must be paid in this order and pro rata by class before any distribution to any heir or legatee. (2) Makes clear the relationship of the affiant to the decedent. (3) Makes another acknowledgement that the claims must be paid before any distribution to any heir or legatee and agrees to indemnify creditors of the estate, the heirs and legatees, and anyone else relying on the SEA who incurs any loss because of any act or omission by the affiant. Indemnification will also include reasonable attorney's fees and the

expenses of recovery. (4) Any person, corporation, or financial entity that acts in good faith in reliance on a SEA that is substantially in compliance with this Act is fully protected. (5) Provides that the affiant (instead of other specified persons) may in writing appoint one or more persons, or himself or herself, to access the safe deposit box of a decedent. Provides that the lessor shall authorize a representative of a decedent's estate or a person designated in a small estate affidavit, upon presentation of letters of office, other applicable court order, or small estate affidavit, to open the box and examine and remove the contents.

IMDMA. House Bill 5425 (Cabello, R-Rockford) Amends the Illinois Marriage and Dissolution of Marriage Act. Recognizes in the aspirational part of the Act that the involvement of each parent for equal time and not less than 35% of residential parenting time per week is presumptively in the children's best interests. Provides that in cases in which the court finds that it is not in the best interests of the child for the parents to have equal time or that it is not possible for both parents to share time equally, a minimum of 35% residential time per week should be ordered for the non-custodial parent. It allows the non-custodial parent to waive his or her right to a 35% minimum residential time per week. Provides that parents may agree to an alternate parenting schedule, subject to the court's approval.

Loans to litigants. Senate Bill 3169 (Haine, D-Alton) creates the Non-Recourse Civil Litigation Funding Act to regulate lending to litigants. Requires that all contracts for non-recourse civil litigation funding must be written, provide the total funding amount to the customer, itemize one-time fees, and allow the customer to cancel contract within 10 business days following receipt of the funding amount without penalty or further obligation. Any attorney's fee, Medicare lien, Medicaid lien, or health-care provider lien takes priority over any lien of the non-recourse civil litigation funding company. �

Using cloud computing to practice more effectively

ne of the first columns that I wrote for this publication was about cloud computing. At the time, the question facing most attorneys was whether they could use cloud computing and still comply with the ethical rules. Since then, that ethical question has essentially been answered.

Although the exact specifics vary, the ethical bodies that have reviewed the issue concluded that attorneys may ethically integrate cloud services into their practice. A summary of these decisions can be found at that ABA's Legal Technology Resource Center at tinyurl.com/733gyr8.

Given that the consensus is attorneys may integrate cloud services into their practice, questions arise as to what cloud services are available and how they can assist attorneys.

The idea behind cloud services is that they are

provided by a company via the internet. By doing so, the provider makes the product or service available to you from anywhere that you have an internet connection. Also, many of the services that are discussed in this article also have apps that make it easy for you to access these services from either your tablet or smartphone.

Document Storage

One of the most popular uses of cloud services for attorneys is to store documents. With the legal profession becoming more and more mobile, attorneys often need to access documents while out of the office. Whether you need to review files in court or during client meetings, the ability to pull up a client file on a laptop, tablet or smartphone is not just convenient but a critical part of many attorneys' practice.

Cloud-based technologies allow this to occur. Instead of storing your documents in your office on a server that you must maintain and replace. You can, instead, use a cloud based service to store those documents and make them available to you (and anyone else you want) anywhere that you can access the internet. Further, some of the services allow you to synchronize your stored documents so that they are available both in the cloud and on your local hard drive.

Popular services that provide document storage include Dropbox (www.dropbox.com), SpiderOak (www.spideroak.com), Box (www.box.com), and Net-Documents (www.netdocuments.com).

Email

Another popular use of cloud services is for email. With respect to email, you have essentially two choices for a business-grade cloud solution. First, you can opt for Google Apps for Business. (www.google.com/apps/ intl/en/business/). If you are a Google or a Gmail fan, this is a great solution for you. It gives you the power of Google to handle your email tasks. Additionally, it is designed to work with your own domain, so you can maintain your custom email address.

Keep in mind that this product differs from the free Gmail that is available to everyone. With Google Apps for Business, you are paying for the use of a service, you have different terms of service (more favorable to you), and you have rights to your email that you do not get with a free account.

The other option is to use a hosted Microsoft Exchange Server. This gives you the full benefit of an Exchange Server without the costly upgrades and the need to have someone regularly monitor and maintain your Exchange Server.

Either of these solutions works well and will meet your needs. Further, both are competitively priced at about \$5 per user per month. This is one of the best deals out there. If you are still using a free email solution or a POP3 email, I urge you to check out one of these solutions.

Practice Management

Another area in which cloud services are particularly popular is with practice management solutions. Because you can access these services from anywhere, you have access to all of the information in your practice management system anyplace that you have an internet connection.

Cloud-based practice management solutions typically include features such as the ability to keep contacts, calendars and to-do lists, track time, add notes, and link to documents. This is all done in a matter centric manner, so that the particular case that you are working on is the focus of the software. Some of these services allow you to integrate with document storage cloud services such as Dropbox and Box.

Popular practice management solutions include Clio (www.goclio.com), Rocket Matter (www.rocketmatter.com), MyCase (www.mycase.com), LexisNexis Firm Manager (www.firmmanger.com), Adovologix (www. advologix.com), HoudiniESQ (www.houdiniesq.com), and Credenza Pro (www.credenzasoft.com). Please note that HoudiniESQ also has a local, non-web based version. Also, Credenza Pro is a hybid product in that it integrates with Microsoft Outlook, so that part of the service is installed locally, and the remainder of the service is over the internet.

Hosted Law Firm

The latest trend with cloud services has been to move all of a firm's applications to the cloud in a hosted environment. This is a great solution if you have a lot of traditional software that you want to use, or if you are already invested in a traditional time and billing system or practice management system.

What these services do is provide you with computing space to store and run all of these applications from. No one has these applications installed on their individual workstations. Instead, everyone accesses all of their programs over the internet.

With a solution such as this, you don't have to worry about reinstalling software when the hard drive on one of your computers crashes. Instead, you simply go to a different computer, log back in, and it is as though your computer never crashed.

The downside to this solution, of course, is that if your internet is slow or goes down, you are out of luck.

Companies providing a service such as this include Uptime Systems (www.uptimesystems.net), Legal Workspace (www.legal-workspace.com), and Cloud 9 (www.cloud9realtime.com).

If you have ever been somewhere other than your office and wished you could access a critical piece of information, then I urge you to explore some of the options that cloud computing offers. Not every service is right for everyone. However, there is likely a service out there that would allow you to practice law more effectively. ❖



Finding, hiring and retaining top associate attorneys

Are you getting the right associates on the bus for the long term?

any senior partners in law firms are approaching retirement age and are beginning to think about succession strategies. As they examine their associate lawyer ranks some partners are often surprised to learn that there may be few takers. While their associates may be great lawyers, none bring in business or seem to be interested in partnership. Such firms have hired a bunch of folks that just wanted jobs and have no interest in owning a law firm. While this hiring approach may have satisfied the firm's short term needs – it may fall short in the long term.

Hiring For the Long Term

Years ago it seemed that all the associates working in law firms wanted to eventually become a partner in the law firm. This has changed as a result of the new mix of women and men graduating from law schools and entering the legal profession, changing attitudes toward work life balance, other opportunities outside law firms, and other variables. While partnership/ ownership is still important to many - don't assume all the associates you hire will even want to be equity partners - especially if it means a hefty capital contribution and signing personal guarantees for a large amount of firm debt.

A question that I would ask - have you really discussed with your associates their interests in equity ownership? As a group? Recently an associate, whom the firm had written off, advised me that while he was not interested now due to his present situation in life, he would be in maybe five years – especially if others also were brought in as well. In other words, he did not want to have the responsibility alone and be an equity owner by himself.

I suggest that you talk with your people and see where they really stand. Help them to begin acquiring client development skills. Depending on you and the other partner's retirement timeline - you may have to consider other options such as laterals or merging with another firm.

A key suggestion is to look for entrepreneurial associates when you hire. The desire for ownership of a business is often in a person's blood. Don't start the interview with a discussion from law school until the present. Dig deeper into hobbies, family, etc. which will provide clues as to whether you may be hiring someone who just wants a law job or someone who eventually wants to own or be a partner in a law firm.

Implement a Law Firm Associate Career Progression/Partnership **Admission Program**

A common complaint that I hear from interviews of associates is lack of feedback on short term performance, what is takes to "make partner" and how they are progressing toward eventual partnership. During a recent interview an associate told me – I would like to know:

- 1. What does it take to become a partner consideration criteria? What do I have to do?
- 2. What is the timeline for consideration?
- 3. How am I doing am I partnership material?
- What does partnership mean in this firm?
- What are the mechanics of admission? (Is there a buy-in)



I suggest that you and your partners consider developing what I call a Law Firm Associate Career Progression/Partnership Program and put it in writing. Here is an approach you might take:

- 1. Determine if you want more partners? How many evaluate the appropriate ratio.
- Consider non-equity partners as a first step and determine what that means.
- Establish a minimum number of years for consideration i.e. seven years.
- Determine competencies and expectation for associate development and
- Develop an associate performance evaluation form and conduct formal annual evaluations.
- Develop partner admission criteria (associate to non-equity and non-equity to equity partner) and document.
- Write up an overall program document and include as attachments the competencies document, the performance evaluation form, and the admission criteria document.
- Present the program to associates in a live meeting format to launch the program.

Regarding equity partnership – make the criteria tough – and require a buy-in or capital contribution. Business development and a client following should be required by most firms for the equity tier.

Associate Performance Evaluations

One of the most frequent complains I hear during interviews with associates in law firms of all sizes is lack of specific detailed feedback, unclear or non-existent expectations concerning their performance and future career progression, and vague informal performance reviews.

Here are a few suggestions:

- Institute a system where associates, especially when they are new, have a chance to work with all of the partners in the firm.
- As managing partner, solicit feedback from your partners and meet monthly with each associate and discuss their performance during their first two years of employment with the firm.
- Annually conduct formal performance reviews with each associate. Before the review obtain specific feedback from each of the partners and have each partner complete a written review of each associate using the associate performance rating form. Ask each associate to conduct a self-evaluation using the firm's associate performance rating form and then conduct a detailed review with each associate. The review should be detailed and specific and should be developmental with specific goals and timelines established. Document the review in the associate performance rating form.
- Consider developing an associate career progression program (partnership track) and committing it to writing. The program should outline the timeline for first consideration for partnership, competencies and performance factors, what partnership means in your firm, how an associate becomes a partner, buy-in or capital contribution requirements, voting, etc.
- Be honest and open with your associates don't try to be Santa Claus tell them the truth, have the difficult discussions, and make the tough calls. Be accessible.

Mentoring Law Firm Associates: Getting the Basics Right


A law firm's greatest asset is its people and your associates are your firm's future. Lack of mentoring is one of the biggest complaints that I hear from associates in on-site interviews. While you may be too small for a comprehensive formal mentoring program, you should at least explore an informal program. Start with baby steps and go from there.

The keys to successful mentoring relationships involve the mentor and mentee deciding on the logistics up front. Many potential mentoring pairs fail to form because the parties did not agree on the little things up front. Below are tips designed to help both participants in formal and informal programs:

- 1. Meeting schedule: Decide on an approximate meeting schedule. Suggest that meetings be scheduled at least once a month.
- Means to schedule meetings: Share the best way to get on each other's calendar.
- Scheduled meetings: Don't wait until the end of one meeting to schedule the next. Always have the next two or three meetings on the calendar.
- Length of program/partnership: For formal programs; the firm may suggest a length of time to meet (usually a year). For informal mentoring, suggest having a date on the calendar to review goals and examine the relationship.
- Confidentiality: Mentors and Mentees need to discuss what confidentiality means to them. It is the foundation of trust, which is the basic currency of mentoring. ❖

A new proposal for the ISBAYLD Children's Assistance **Fund Grant Committee**

or years, the ISBA Young Lawyers Division, in connection with the Illinois Bar Foundation, has raised funds and awareness for the Children's Assistance Fund. That fund seeks to provide grants to organizations across the state related to children and law. Over the past decade, the Young Lawyers Division has raised and awarded over \$197,000 to nonprofit organizations throughout the state of Illinois dedicated to helping children and their interaction with the legal system. As state budgets have declined, more and more nonprofit organizations have turned to alternative funding to carry out their missions. Accordingly, the YLD Children's Assistance Fund has seen an increase in both the number of grant applications as well as the amount of dollars requested.

During the 2013 Bar year, the ISBA YLD Grant Committee has studied the history of the grant awards, applications and fundraising in order to prepare a long range strategic plan recommendation to the YLD Council. Our study has concluded that several alterations to the grant process and fundraising by the YLD should be altered to ensure the continued sustainability of the Children's Assistance Fund.

Grant Application Reform

The Grant Committee study has found that in each of the past three years, the number of nonprofit organizations applying for grants as well as the dollar amounts requested has steadily increased. Further, grant applications are accepted on a rolling basis throughout the fiscal year. All of the awarded funds are the result of fundraising by the Young Lawyers Division's members. For the past two years, the funds awarded have been greater than the amount of dollars contributed to the fund—which has reduced the small amount of reserves accumulated over the past decade.

During the 2012-2013 Bar year (June 2012 through June 2013) over \$45,000 was awarded to Illinois nonprofit organizations including CASA of Lake, Kane and Saline counties as well as the DeKalb County Youth Services Bureau. This was a steep increase above the \$19,700 awarded in FY 2011. Unfortunately, the Children's Assistance Fund cannot always award the full amounts requested by applicants. For example, recently the Grant Committee reviewed grant applications from several organizations, and if each application received the full amount awarded, the award would exceed \$45,000, leaving no remaining funds for other organizations for the rest of the fiscal year.

Based on these findings, the Grant Committee recommends that the YLD and Illinois Bar Foundation institute an annual grant application period with a firm deadline. This will accomplish two important goals: 1) the Grant Committee (and YLD Council) will be able to establish a budget and establish fundraising goals so that deficits do not threaten the viability of the fund; and 2) grant applicants will be evaluated at the same time and not subject to availability of funding later in the fiscal year. The exact timing of the deadline has not been determined at this time, however any implementations are aimed to take place beginning in the 2015 Bar year.

Fundraising Reform

Because every dollar awarded for approved grants comes from the fundraising activities of the YLD, evaluating the fundraising efforts of the YLD has been a

second focus of the Grant Committee's study. That study has evaluated dozens of YLD hosted events that have taken place over the past decade including the annual Holiday Party, Soiree, Bean Bag Tournament, Golf Outings, etc. The analysis of these events is aimed to determine which events are (were) successful, and how "success" is defined.

It is axiomatic that the mission of the YLD is to serve as a resource for young lawyers practicing in Illinois to develop, enhance, and foster a balanced professional life. In furtherance of that mission, the YLD sponsors and hosts events that allow lawyers from all over the state, across every practice area to meet outside the confines of our offices and courtrooms. Several of these events also serve the dual purpose of raising funds for the Children's Assistance Fund. With the increased debt burden and employment challenges facing recent graduates, in the past few years, the YLD has tried to focus on providing low or no-cost events that encourage greater participation by all members. It is with these findings the Grant Committee recommends that 1) the YLD set an annual fundraising goal; and 2) explore alternative fundraising structures including annual or semiannual sponsorship of the Division's events in addition to single-event fundraising. These proposals, if adopted by the YLD Council, will allow for members to provide needed funding to the Children's Assistance Fund and continue to host low or no-cost events available to all young lawyers.

Again, the spirit of the YLD is to foster a balanced professional life that will guide the careers of our members. The Grant Committee has worked over the past year reviewing records and spending many lunches on conference calls and debating issues. A full report is being prepared that will be distributed to the full YLD Council and it is anticipated that resolutions will be proposed and potentially adopted during the YLD's Annual Meeting in June. Community Leadership Award

The recipient may be a lawyer or non-lawyer or an organization of lawyers or a combination of both. Deadline for Nominations is April 4, 2014.

Law Student Division Public Service Award

The ISBA Law Student Division's Public Service Award is awarded annually to a law student participating in activities that enhance professional responsibility and provide service to the public. The award is based on extracurricular accomplishments and service related activities during the law school career.

A finalist will be selected from each accredited law school affiliated with the ISBA Law Student Division from which qualified nominees are submitted. The final award recipient will be chosen from these finalists. Each winner will receive a commemorative plaque. The final award recipient will receive all expenses paid to the ISBA Annual Meeting including transportation and one night's lodging and will be honored at the Awards Luncheon. A \$250 donation to a



Lawyers Care stories highlight profession's giving nature

Lawyer Devotes Life to Mentoring Others

ISBA 3rd VP Vincent F. Cornelius knew at a very young age he wanted to be a lawyer, and not just any lawyer but the primary shareholder in his own firm by the age of 30. He reached that milestone and has gone on to enjoy a successful 18-year career in private practice with a concentration in criminal defense.

But it's his eagerness to serve as a role model and mentor that sets him apart. A native of Joliet, Cornelius sees many of his childhood friends when he walks through the Will County Courthouse. Some are lawyers, but others have ended up on the wrong side of the law. His true calling, he believes – almost a ministry of sorts – is helping those in need, be they people who made wrong choices and want to change, or law students of color who need extra support.

As one of only two black students in his graduating class at NIU College of Law, Cornelius was distressed to learn about the significant dropout rate among black students at the school. After graduating, he set about reversing that trend and enlisted some of his law school buddies to return to NIU for a few days and help black law students study for their midterm exams. Slowly over time, the tide began to turn, and the percentage of black students who graduated increased.

One of the many success stories is Chrystel Gavlin, who, under Cornelius' tutelage, went on to graduate from NIU and practice law. Today, as an associate judge in Will County, she is quick to credit Cornelius and his friends with the help and encouragement they provided. ❖

Lawyer-Veteran Helps Other Vets Get Disability Benefits

An 89-year-old World War II veteran is now receiving back pay and monthly disability benefits from the Veterans Administration, after a Chicago area lawyer provided pro bono legal assistance to cut through red tape.

Joseph Groner developed cancer from exposure to radiation as an Army X-ray technician serving in both the European and Pacific theaters. After a frustrating four years to get back pay and disability, he got the help he needed from lawyer Frank Del Barto, an associate in the Schaumburg office of Masuda, Funai, Eifert & Mitchell Ltd.

Himself a veteran, Del Barto is among 350 volunteer lawyers who represent military veterans on a pro bono basis through The John Marshall Law School's Veterans Legal Support Center & Clinic (VLSC).

Groner's story is typical of many veterans who find considerable roadblocks in receiving payment for their claims. Having a lawyer involved can make a big difference because the lawyer helps the veteran put together information in a logical way to present the appropriate legal arguments to the Veterans Administration. The Groner case was the third one Del Barto has successfully handled for the VLSC. He is currently working on claims to help an additional

When Del Barto needed to get his own disability benefits as a result of his military service in the Army from 1987 to 1991, he was able to represent himself. He had a leg up because of his legal training, but he understands that most veterans don't have that advantage. �

DePaul Law Student Gets Head Start on Volunteering

Brandon Clark came to DePaul University College of Law with public service on his mind. And if his volunteer activities as a student are any indication of what's to come after graduation, the public will be well-served.

Recently, he led a group of fellow students on a trip to Washington, D.C. as part of a DePaul-sponsored service immersion program. Founded in 2005, the program's initial trip was organized in response to Hurricane Katrina. In 2010, the annual trip was expanded to include Washington to help the homeless and others who live on the margins of society.

Clark participated in that first trip to D.C., but this was his first year as a trip leader. His team worked at various food pantries, assisted at a homeless shelter, and helped the Washington Legal Clinic for the Homeless update its volunteer

Two years ago, Clark made waves of a different kind – at Chicago's Shedd Aquarium where he received a fellowship to participate in an eight-week summer program to explore environmental law. Mentors in the project included the Shedd's conservation experts and a practicing environmental lawyer.

This third-year law student isn't above having a little fun in his effort to help others. Last November, he formed the Handlebar Association, a group of fellow law students who ended up raising nearly \$1,400 for charity as part of a monthlong campaign called "Movember": individuals raise donations and compete for the furriest, fuzziest beards possible. �

Lawyers Provide Pro Bono Support for Holocaust Documentary

Pro bono work can be heart-felt and also heart-wrenching.

For Howard Swibel and Judith Grubner, partners at the Chicago law firm of Arnstein & Lehr, it was both as they provided free contractual and intellectual property advice to a Chicago filmmaker, Todd Whitman, who created a historical documentary about a painful subject: the 1977 march staged by neo-

The 60-minute documentary, "Skokie: Invaded, But Not Conquered," is a project of the Illinois Holocaust Museum and Education Center. It has aired on WTTW-TV in Chicago and will be shown nationally on PBS in April 2014. The film recently won two Emmy awards.

At the time, residents of Skokie - home to thousands of Holocaust survivors and their descendants - fought back against the neo-Nazis by taking their battle to court. (Ultimately, the neo-Nazis didn't march in Skokie but in Chicago.) The fight, which gained national attention, led to the formation of the Holocaust Museum. It also led to Illinois becoming the first state to mandate Holocaust education in public schools.

The extensive legal work for the documentary involved reviewing permissions for TV network footage, historical interviews, and excerpts from other films to make sure there were no copyright or trademark issues. Swibel and Grubner reviewed the film numerous times to ensure there were no errors.

The two lawyers have admitted they found it tough to review the footage from a strictly legal standpoint. Personal emotions surfaced. Working on the project enabled Grubner to work through some of the issues from her past: her father is a Holocaust survivor. Swibel, who was moved by the educational appeal of the film, now sits on the museum's Board of Trustees. �


